1.1.1 – Institution has the mechanism for well planned curriculum delivery and documentation. Explain in 500 words

Navjeevan Law College, Nashik offers LL.B. (Three Year Course) and B.A.LL.B. (Five year Course) and two diplomas i.e. Diploma in Taxation Laws and Diploma in Labour Laws and Labour Welfare. The College implements the curriculum

designed by the Savitribai Phule Pune University effectively as per the module prescribed by the Bar Council of India and as per the vision and mission set by Navjeevan Education Society. Before the commencement of first semester, our College conducts a meeting to chalk out academic planning through academic calendar. According to the Academic planner, the distribution of subjects and preparation of time table takes place which mentions the date of commencement and conclusion of academic session and communicated well in advance. Academic calendar provides the minute planning regarding curricular, co-curricular and extra-curricular activities in academic year. The institution provides the facility of counseling to the prospective students and their parents regarding the career in law, opportunities in law, and various streams under law etc. After admission process, in the beginning of the academic year, an ice-breaking session is organized to make new students well acquainted with the institution, objectives of the curriculum, placement, evaluation pattern and internship etc. and other activities and programmes are organized throughout the academic year. All the staff members prepare their teaching and working plans and submit it to the Principal for the supervision and periodic review. The regular teaching staff and visiting faculty members adopt different methods and techniques for effective teaching learning process. In view to bridge a gap between Law in theory and Law in Practice, Navjeevan Law College gives equal weightage to the practical aspect of legal education which comprises participative, experiential and problem solving learning method and arranges various activities like court visits, jail visit, police station visit, moot court competitions, elocution competitions, articles, seminar, workshop, guest lectures, other visits and different cultural activities etc . The institution has its placement cell which provides internship in various courts, district legal service authority and legal aid clinics. The institution caters overall development of a student which believes in continuous evaluation and arranges revision and remedial classes. Feedback from students and stakeholders is taken every year and acted upon for the betterment of the institution and society after proper analysis.

The institution organizes programmes for personality development and communication skills essential for law profession. The institution has the separate examination cell with Chief Examination Officer (C.E.O.) as its head which carries continuous internal assessment of all students. The Institution has rich library resources with electronic data base and reading facilities. The Institution conducts a term-end exam in the college before university exam and provides counseling for the preparation of final exam.

Mentorship is a relationship in which a more experienced or more knowledgeable person helps to guide a less experienced or less knowledgeable person. It is a learning and development partnership between experienced and someone who wants to learn. Mentoring is a process that always involves communication and its relationship-based, but its precise definition is elusive. The mentors have taken up the responsibility of students' extracurricular activities. The Moot Mentor helps the students in internship and externship placements. The mentors also try and explain law students the difference between learning and practice and try to initiate monthly contact with the students. Both local and in-person meetings of students and mentors are scheduled well in advance. Class Mentors encourage group discussions, lecture series and also distribute topics on which the students prepare presentations and present it in the class. This technique helps the mentee to understand and analyze the topic thoughtfully and effectively. Mentors prepare questions, discussion topics, and material in advance before meeting the mentee.

#### 7.1.7 – Initiatives taken by the institution to make the campus eco-friendly (at least five)

#### 7.2 - Best Practices

1. Legal aid clinic- Social Responsibility The activities under legal aid clinic are given priority by the management and the college administrators. The legal aid clinic is authorized by the Maharashtra state legal services authority Mumbai. So we are accountable to the above authority for conducting the various activities under the cell. Looking to the importance of the object, the college has established a permanent office of the legal aid clinic in the law college premises. It includes the counseling room, visitor's room and a waiting room for the law affected persons. Mr. J. C. Shirsale Rtd. District Sessions Judge Nahik use to sit in the legal aid clinic daily from Monday to Friday 10 am to 2 pm for guiding the persons having legal problems. The final year students are divided in the batches so that they can help the faculty member the experts while giving legal aid and counseling the poor and needy persons. It is helpful for the students to know the actual problem of the

The important activity of the legal aid clinic is to conduct legal awareness programs in the rural areas. The colleges has conducted the legal awareness programs and make aware the poor and needy people about their legal rights and inform them in their vernacular language the various laws including domestic violence, 7/12 extract, consumer protection, family matters, dowry related laws etc. 2. Student friendly atmosphere The admission process for the LL.B (3 years) and B.A.LL.B (5 years) has been taken over by the Government of Maharashtra. All the admissions are made by a common entrance test (CET) conducted throughout the state of Maharashtra. The aspiring candidates for taking law admissions to the law courses were puzzled and faced many difficulties and problems regarding filling of the CET examination forms and appearing the examination. As many of them were not aware about the CET process, they were not able to get admission in that academic year. Looking to the chaos, the Navjeevan Law College formed the Admission committee at the college level. The candidates making enquiry for the admission purpose were given full information about the making of the application for the CET examination, Format of CET examination, result, online application of choosing of Law colleges, and the rounds for the actual admission in the law college etc. This become a very helpful tool for the candidates to resolve their problems regarding their admission process in the Law colleges. The various committees formed by the college for e.g. Document verification committee, Right to information committee, Anti-ragging committee, Internal compliant committee, Screening committee etc. are always proved to be beneficial for the students to have friendly touch with the faculty members, teaching and non-teaching staff. Students are always have free access regarding their admission problems, examination problems, other doubts relating to career matters, relating to various competitions organized by the other colleges etc. to the principal, teaching and non-teaching staff members. This healthy environment certainly will help the students for getting solution to his problem smoothly without any hassle and hurdle.

#### 7.3 - Institutional Distinctiveness

7.3.1 – Provide the details of the performance of the institution in one area distinctive to its vision, priority and thrust in not more than 500 words

Navjeevan Education Society's Navjeevan Law College is having a specific distinctiveness where the students are consider being center point of all the Law college activities. As the law college is situated in the area where the working class laborers are more in number the student always faced many problems which includes technological unawareness, vernacular medium problem, communication skill problem, presentation skill problem etc. The students who are coming from rural areas with the limited access could not cope up with the rapid pace of urban and collegiate environment with medium of instructions and examination being in English language. Moreover the entire syllabus is in English and the books available in the market related with law subjects are in English only. This is other vital drawback. It affects the comprehensive capacity of the student to grasp the spirit of the particular subject. This ultimately resulted in to the dropping out rate of some students from the law courses. The final result is also comparatively affected due to this major problem. To cope up with this problems Navjeevan Law College have taken special measures such as remedial teaching methods including extra English speaking and communication skill classes, personality development programs, exposure to the

students to participate in various moot court, debate and elocution competitions organized by the college and other institutions. The students not having economic capacity to pay the fees of the college are provided full guidance for getting Government scholarship, Freeship and other fees concessions which includes paying of the total fees in installment also. Though the college is not having its own hostel but the students who are interested in taking admission are provided all necessary help to obtained admission in government / private hostel or private rooms on rent/ paying guest basis. The college is having placement cell and through the placement cell the students are guided for grabbing the various opportunities available in the law and other fields. Through this cell students are guided for the various competitive examinations including JMFC and CJJD examination.
