1. It is observed that students have ranked majority of the faculty members above the satisfactory mark.

2. It is important to point out again that no one data source or methodology will sufficiently answer all critical educational questions.

3. Multiple measures or indicators of instruction are needed to help capture a more comprehensive picture of what goes on in classrooms. Some of the new directions for classroom observation research include the following:

(1) Combining both qualitative and quantitative methods in observation systems

(2) Developing observation instruments that are based on "standards" of pedagogy

(3) Using student-centered observation instruments that allow for comparisons between groups of students within the class; and

(4) Using instruments that assess authentic, interactive instructional practices that have been found to relate to student gains on higher-level cognitive outcomes.

Action taken:

The observations received are forwarded to the principal, CDC and IQAC for further necessary action and to be implemented from the next academic year.
