In pursuance of the decision taken by the University authorities, following are the Eligibility Criteria for the various Law courses:-

- 1. LL.B. Ist year (Three year Law Course)
 - a. Any Graduate or Post Graduate of recognized university securing more than 45% marks.
 - b. 40% for Schedule Caste and Schedule Tribes students only.
- 2. B.A. LL.B. Ist Year (Five years Law Course)
 - a. Higher Secondary School Certificate Examination (10+2) or its equivalent with 45% marks.
 - b. Three Years Diploma Examination of Board of Technical Education (After 10th Std.) with 45% marks.
 - c. 40% for Schedule Caste and Schedule Tribes students only.
- 3. D.T.L. (Diploma in Taxation Law) One Year Course.
 - a. Bachelor's Degree in any Faculty / Stream.
- 4. D.L.L. & L.W. (Diploma in Labour Law and Labour Welfare) One year course.
 - a. Bachelor's Degree in any Faculty / Stream.

ELIGIBILITY FOR LAW COURSES

ADMISSIONS TO FIRST YEAR OF Three Year Full Time Regular Degree COURSE In Law VIZ. LL.B 3 YEAR FOR THE

ACADEMIC YEAR 2021 - 2022

As per the Maharashtra Unaided Private Professional Educational Institutions (Regulation of Admissions and Fees) Act, 2015 (Mah. XXVIII of 2015), the Competent Authority is conducting CET [MAH-LL.B 3 YEAR CET-2019] for admission to Three Year Full Time Regular Degree Course in Law VIZ. LL.B 3 YEAR. The Online Applications are invited for CET for ADMISSIONS TO FIRST YEAR of Three Year Full Time Regular Degree Course in Law VIZ. LL.B 3 YEAR in the Government, Aided and Unaided Institutes in the Maharashtra State.

Eligibility Criteria for appearing to MAH-LL.B 3 YEAR CET- 2021-22:

The candidate should be an Indian Citizen. The candidate belonging to the type [NRI, PIO, OCI and Foreign National Students] with following Academic Eligibility is not required to appear for CET. They must only apply for CAP rounds.

- (a) Candidate should be a graduate in any faculty of any University in Maharashtra established by an act of Parliament or by a State Legislature or an equivalent National Institution recognized as a Deemed to be University or Foreign University recognized as equivalent to the status of an Indian University by an authority competent to declare equivalence, with minimum 45% of Marks in aggregate (That is 45 % marks for all the parts of the Degree Examination taken together), (candidate belonging to SC/ ST Category need only 40%marks in the qualifying examination.)
- (b) An applicant who has passed the U.G degree and or 2/3 years P.G degree from University mentioned in (a) after processing the studies in the pattern of 10+2+3 or 10+2+3+2/3 with regular studies at secondary and higher secondary schooling is eligible, Provided that, the applicant who have obtained First Degree Certificate by distance or correspondence method shall also be considered as eligible for CET of the 3 Years Law Courses. (the applicant who has passed the qualifying examination (10+2, U.G. & or P.G.) in a single sitting examination without having basic qualifications of (10+2+3) is not eligible.)

Further provided that, no candidate from the Open University having a degree contrary of the U.G.C. Act and regulations and contrary to Rules of Legal Education shall be eligible.

Further provided that, candidates who are appearing/appeared for the qualifying examination (regular examination of that academic year) are also eligible to apply for the Entrance Examination. Such candidate become eligible for admission only if they produce the provisional / Degree certificate of the qualifying examination and the mark lists of all parts of qualifying examination at the time of CAP application form filling.

ADMISSION TO FIRST YEAR OF Five Year Integrated Full Time Regular Under-Graduate Degree Course In Law, Viz. LL.B 5 YEAR FOR THE ACADEMIC YEAR 2021-2022

As per the Maharashtra Unaided Private Professional Educational Institutions (Regulation of Admissions and Fees) Act, 2015 (Mah. XXVIII of 2015), the Competent Authority is conducting CET [MAH-LL.B 5 YEAR CET-2018] for admission to the First Year of Five Year Integrated Full Time Regular Under-Graduate Degree Course In Law Viz. LL.B 5 YEAR. The Online Applications are invited for CET for ADMISSION TO FIRST YEAR OF Five Year Integrated Full Time Regular Under-Graduate Degree Course In Law, Viz. LL.B 5 YEAR in the Government, Aided and Unaided Institutes in the Maharashtra State

ELIGIBILITY CRITERIA FOR APPEARING TO MAH-LL.B 5 YEAR CET-2021:

The candidate should be an Indian Citizen. The Candidate belonging to the type [NRI, PIO, OCI and Foreign National Students] with following Academic Eligibility is not required to appear for CET Examination. They must apply only for CAP rounds.

(a) An applicant who have successfully completed Senior Secondary School course (+2) or equivalent (such as 11+1, A level in Senior secondary School Leaving Certificate course) from a recognized university of India or outside or from Secondary Board or equivalent, constituted or recognized by the Union or by a State Government or from any equivalent institution from a foreign country recognized by the government of that country for the purpose of issue of qualifying certificate on successful completion of the course Examination, with minimum of 45% marks in aggregate (candidate belonging to SC/ ST Category with minimum 40% marks) (b) The applicants who have obtained +2 Higher Secondary Pass certificate or First Degree Certificate after processing studies in distance or correspondence method is eligible for the course. Provided that, the applicants who have obtained 10+2 through open university system directly without having any basic qualification are not eligible, Further provided that, applicants who have obtained 10th std./Secondary Schooling Certificate Examination, in a single sitting examination without having basic qualification (1st to 9th standard of schooling) is not eligible.

Further provided that, the candidates who are appearing/appeared for the qualifying examination (regular examination of that academic year) are also eligible to apply for the Entrance Examination. Such candidate will be eligible for admission only if they produce the proof of qualifying examination and the mark lists of all parts of qualifying examination at the time of admission.

There is no Upper age limit for admission to 5 year's LL.B Course.

REFUND OF FEES

If a Student chooses to withdraw from the program of study in which he is enrolled, the College/ Institution concerned shall follow the following five tier system for the refund of Fees remitted by the students

¹⁾ In case of Sr. No. (1) in the table above, the college/Institution concerned shall deduct all amount not more than 5% of the fees paid by the student, subject to a maximum of Rs. 5000/- as processing charges from the refundable amount.

²⁾ Fees shall be refunded by all college / Institution to an eligible student within fifteen days from the date of receiving a written application from him/her in this regards.

PART II

Eligibility for Admission for B.A. LL.B., B.B.A. LL.B. and LL.B. Courses

- 1. Qualifying Examination for Admission: (1) B.A. LL.B. and B.B.A. LL.B.: An applicant who has completed Senior Secondary School Course (10+2) or equivalent (such as 11+1, 'A' level in Senior School Leaving Certificate Course) from a recognized University of India or outside or from a Senior Secondary Board or equivalent, constituted or recognized by the Union or by a State Government or from any equivalent institution from a foreign country recognized by the government of that country for the purpose of issue of qualifying certificate, on successful completion of the course, may apply for and be admitted to (i) First Year of B.A. LL.B. or (ii) First Year of B.B.A. LL.B., as the case may be.
- (2) LL.B.: An applicant who has graduated in any discipline of knowledge from a University established by an Act of Parliament or by a State legislature or an equivalent national institution recognized as a deemed to be University or foreign University recognized as equivalent to the status of an Indian University by an authority competent to declare equivalence, may apply for and be admitted to First Year of LL.B.

Provided that applicants who have obtained 10+2 Higher Secondary School Certificate or First Degree Certificate after prosecuting studies in distance or correspondence method shall also be considered as eligible for admission to (i) First Year of B.A. LL.B. or (ii) First Year of B.B.A. LL.B. or (iii) First Year of LL.B., as the case may be.

Explanation: The applicant who have obtained 10+2 or graduation / post graduation through Open University system directly without having any basic qualification for prosecuting such studies is not eligible for admission to (i) First Year of B.A. LL.B. or (ii) First Year of B.B.A. LL.B. or (iii) First Year of LL.B., as the case may be.

- (3) The eligibility for admission, for any class / year other than first year / class of any law course, of a student migrating / transferring from any other recognized University to this University shall be subject to the rules of this University made from time to time.
- **2. Minimum Marks in Qualifying Examination for Admission**: (1) A candidate passing Higher Secondary School Certificate Examination (10+2) or its equivalent, as prescribed by the Bar Council of India or the University, with minimum 45 % marks shall be eligible to apply for admission to (i) First Year of B.A. LL.B. or (ii) First Year of B.B.A. LL.B. There shall be relaxation of 5 % marks in case of scheduled caste and scheduled tribe candidates.
- (2) A candidate passing Bachelor's degree examination or its equivalent in any faculty of this University or any other recognised University, as prescribed by the Bar Council of India or the University, with minimum 45 % marks shall be eligible to apply for admission to First Year of LL.B. There shall be relaxation of 5 % marks in case of scheduled caste and scheduled tribe candidates.

PART II

Eligibility for Admission for B.A. LL.B., B.B.A. LL.B. and LL.B. Courses

- (3) If the candidate has obtained 44.5 % marks or more in qualifying examination for admission is permitted to be rounded off as 45 % marks for the purpose of admission to (i) First Year of B.A. LL.B., or (iii) First Year of LL.B., as the case may be.
- (4) Similarly, if the candidate belonging to scheduled caste or scheduled tribe category has obtained 39.5 % marks or more in qualifying examination for admission is permitted to be rounded off as 40 % marks for the purposes of admission to (i) First Year of B.A. LL.B., or (ii) First Year of B.B.A. LL.B., or (iii) First Year of LL.B., as the case may be.
- (5) Such a minimum qualifying marks shall not automatically entitle a person to get admission into an institution or college but only shall entitle the person concerned to fulfill other criteria notified by the institution / college concerned or by the University or by the Bar Council of India or by the government concerned from time to time to apply for admission.

Explanation: The candidates for Scheduled Caste and Scheduled Tribes categories should be those declared as Scheduled Caste and Scheduled Tribes for the State of Maharashtra.

- **3. Prohibition to Register for two Regular Courses of Study:** No student shall be allowed to simultaneously register for a law degree programme with any other graduate or postgraduate course run by the same or any other University or an Institute for academic or professional learning.
- **4. Prohibition against Lateral Entry and Exit**: (1) There shall be no lateral entry on the plea of graduation in any subject or exit by way of awarding a degree splitting the integrated double degree course, at any intermediary stage of integrated double degree course.
- (2) The term "lateral entry" means an admission given to graduate applicants at the beginning of third year in an integrated five year course.
- (3) The term "lateral exit" means opting out at the end of three year after successfully completing the courses up to the third year, from an integrated five year course on being awarded a bachelor degree.
- **5. Miscellaneous Rules of Eligibility for Admission :** The rules given herein are for the general understanding of the candidates. However, the admission to (i) First Year of B.A. LL.B., (ii) First Year of B.B.A. LL.B. and (iii) First Year of LL.B. shall be subject to the rules made and conditions prescribed, from time to time, by the University, Central Government, State Government, Bar Council of India, University Grants Commission, or any other authority empowered.

Date of Issue of Application Form and Admission Open as per MH-CET cell notification ADMISSION PROCEDURE AND RULES

- 1. Admission to all courses is made as per the schedule of MH-CET Cell / S.P.P.U. Circular. Students are advised to see / Check College Notice Board and MH-CET / S.P.P.U. Website for the same.
- 2. Admission to First year of Three Year Full Time regular Degree Course in Law Viz LL.B. 3 Year on the bases of Government of Maharashtra and Savitribai Phule Pune University Instruction and direction made from time to time and shall be finalized after complition of admission process.
- 3. Application for admission duly completed shall be accompanied by remittance of necessary fee, required original Certificates.
- 4. Generally following documents are required (Along with Original Certificate)
 - a. Passing Certificate of the Qualifying Examination.
 - b. Statement of marks of Qualifying Examination.
 - c. Transfer Certificate / Leaving Certificate (No bonafide Certificate will be consider)
 - d. Migration Certificate (In case of other than Pune University)
 - e. Two Photo Copies of each Certificate.
 - f. Two passport Size very recent photographs.
 - g. Affidavit for Educational Gap.
 - h. Caste Certificate.
 - i. Certificate for date of birth (Matriculation Certificate)
 - j. Character Certificate from the college last attended (In case of other than Pune University)
 - k. Money receipt of application form in original.
 - I. Caste Validity Certificate
 - m. Non creamy layer Certificate
 - n. Domicile Certificate
 - o. Nationality Certificate
 - p. Anti Ragging undertaking by Students as per U.G.C. provision. (www.antiragging.in/site/affidavits registration.aspx)
- 5. Mere Submission of application form, for admission with necessary documents does not amount to 'Admission'. The Principal reserves the right of granting admission and every Admssion is required to be confirmed by the concerned authorities of the college and S.P. Pune University.
- 6. Acceptance of application form without Transfer Certificate / Migration Certificate / Cast Certificate / Eligibility Certificate (as the case may be) does not amount to final admission of the candidate. His/her admission is strictly on provisional basis and pending for compliance. (even though his/her name appears on the roll of student and college identity card is issued to them.) The Principal reserves the right of removing the name of such student from the roll of student at any time.
- 7. If admission is granted but same is not availed by the applicant the amount remitted will be forfeited and will not be refunded on any ground.
- 8. If admission is not granted or if the name of such applicant is removed from the roll of students, the amount remitted by the applicant will be refunded after deducting the amount as per rules of the university.
- 9. An applicant migrating from other university is admitted provisionally. The admission of such applicant is confirmed on receipt of final eligibility Certificate from the university. Such provisional admission is at the risk of the applicant.
- 10. Application for admission should be submitted within 30 days from the commencement of the academic year.
- 11. Perusal of Notices displayed on Notice board is mandatory to all admitted students. No personal correspondence will be made with the student for giving any directions / Notices. College will not be held responsible for non-compliance by the students regarding such a notices / directions.

LIBRARY RULES

The library has a rich collection of law books, reference books, journals and periodicals. The Library offers reading room facility to the students to study and for reading News Papers. It also provided home lending facility to the students.

- 1. Library timings are 8:00 am. to 5:00 p.m.
- 2) Every student must possess an identity card with him/her, and must produced it whenever demanded by the college authorities.
- 3) Readers desirous of using the library or taking books should submit their I-card duly signed by the principal as well as enter their names and address rightly in the register kept for the purpose and the signature so recorded will be treated as their acknowledgement to abide by the rules of library.
- 4) Every students will be allowed to take two books. The books has to be returned within 15 days. Books returned after specified period will be fine Rs.1/- per day (including Sunday & Holiday)
- 5) Reference books and periodicals are not issued outside the library. They are not for home lending.
- 6) Students should not right or make any mark upon, or damage any page of a book, journal, manuscript or misuse the properties of the library.
- 7) Readers shall maintain silence within the library premises.
- 8) Students before leaving the reference section should returns the books, journals and manuscripts and other materials to the counter assistant.
- 9) Readers are responsible for damage or injury done to the books, journals or other properties of the library and should compensate the loss caused by them as determine by the librarian.
- 10) Spitting, smoking, eating, talking and reading loudly are strictly prohibited.
- 11) The students should maintain strict discipline at the time of issue and return of the books.
- 12) Penalty for loss of books:
 - a) Before taking a book out of the library students must satisfy himself as to whether the book lent to him/her is in a good condition or not. So he must immediately bring the matter to the notice of the librarian otherwise he his liable to be held responsible for the damaged state of the book.
 - b) If a book of a set is damaged or lost the whole set may have to be replaced and the value as assessed by the librarian and approved by the principal be immediately paid by the borrower.
 - c) In case of a book lost, double the cost with a fine of Rs 50/- or present cost with a fine of Rs. 50/- only will be taken from the borrower.
- 13) All students must return the books to the library on or before respective semester examinations.
- 14) Renewal of the borrowing books:-
 - Loan of books or other materials renewed for further period, provided that not other reader has applied for the same book in the mean time.
- 15) The principal reserves the right to recall the books from the borrower at any time he likes.
- 16) Students must return all books issued to them and obtain "No due certificate" from the library on or before taking his/her hall ticket.
- 17) Refund of Library Deposit:-
 - a) Library deposit will be refunded only after completion of course i.e. Three year of LL.B. degree & Five year of B.A.LL.B. degree and one year diploma course.
 - b) Students left before/ in between completion of course will not be eligible for any refund of library deposit.
 - c) Library deposit not claimed for one year form completion will be forfeited and hence not refunded.

DISCIPLINE

- 1) Every student of the college shall abide by the rules of college.
- 2) Students must observe complete silence and discipline in the college premises. They must not loiter in the passages and corridors after the classes have begun. They are advised to sit quietly in the library and spend their spare time in such a way as not to cause any disturbance with the work of others.
- 3) Every student of the college must follow the dress code in the college premises. Boys: White Shirt & Black Pant. Girls: White Kurti, Black Salvar & Dupatta.
- 4) It is important to note that 75% attendance is required in every semester if the attendance is less, the principal reserves right to cancel such admission or not to allow them to fill up the examination form.
- 5) Every student of the college must have an identity card. He/she should always carry it with him/her in and out of the college and produce it whenever called upon by the relevant authorities.
- 6) In case of loss of I-card, a duplicate card will be issued on submission of an undertaking regarding the loss and payment of fee of Rs. 50/- only.
- 7) No meeting of students will be commenced or notified without the permission of the principal.
- 8) Any unsocial or antinational activity or any act or behavior of any students will vender such students liabel for immediate expulsion from the college without any notice what so ever the decision of the principal is final.
- 9) T. C. to be issued to candidate only after submission of I-Card and other necessary documents.
- 10) Students after completion of the Law Course in any stream those who apply for the T.C. within one year of passing date No Fine. After one year Rs. 100/- for each year.
- 11) Students must keep their terms strictly in accordance with rules of the University and Bar Council Of India
- 12) Use of mobile phone in the college premises is strictly prohibited. Students who apt for mobile use will be subject to disciplinary action.
- 13) Spitting, smoking, chewing guthka, tobacco etc. is strictly prohibited in the college building and college premises within and outside 100 meters / (Yards).
- 14) The college timing will be:
 - a) From 8:00 A. M. to 01:10 P. M. for LL.B (3 years course)

B.A.LL.B (5 years course)

b) From 8:00 A. M. to 12:10 noon for DLL & LW (One year Diploma course)

DTL (One year Diploma course)

ATTENDANCE COMPULSORY

The students should be required to have a minimum attendance of 75% of the lectures in each of the subjects and also at tutorials, most courts, seminars and practical classes.

Student will not be allowed to appear for University Examination unless he put in a minimum attendance 75% as per the University rules.

The admission of students found not attending the lectures, seminars, practical etc. stands cancelled automatically. The decision of the Principal in this respect is final and binding.

The College will conduct Term End Internal Exam after First term and Second Term. Those Students remains absent have to pay fine as directed by the College authorities.

LAW COURSES: NOT EXTERNAL

The LLB (3 Years) B.A.LL.B. (5 Years) Course or any other Course Leading to the University Degree or Diploma under the Faculty of Law of the S.P. Pune University is NOT an External Course. Every Students undergoing any such course, Therefore, must keep terms as per university rules and to the satisfaction of the principal.

Three years LL.B. and five years B.A.LL.B. courses are of semester pattern. The first semester of every academic year will commence from June and will end in November. Second semester of every academic year commences as per the Circular of the S.P.P.U. Student are advised to see University Circular & Notice Board for any change.

A Student may choose optional subjects as per S.P.P.U. Syllabus, Rules / Circular. The college may offer all or any of the groups of optional subjects of specialization at its discretion.

Abbreviations used in Subject Codes: The abbreviations used in the subject codes in the course component of B.A. LL.B. and LL.B. courses shall have meaning as under:

- (a) CE means Compulsory English subject for B.A. LL.B. and courses.
- (b) BA means subject from discipline of Arts for B.A. LL.B. course.
- (c) BB means subject from discipline of Business Administration for course.
- (d) LC means Compulsory Law subject for law courses.
- (e) LP means Compulsory Practical Training subject for law courses.
- (f) LO means Optional Law subject for law courses.

PART IV

Examination Pattern for B.A. LL.B., B.B.A. LL.B. and LL.B. Courses

1. Attendance of Lectures, Internals and Moot Court:

- (1) A student of B.A. LL.B., B.B.A. LL.B. and LL.B. courses shall not be allowed to take the end semester examination if the student concerned has not attended minimum of 75 % of the classes as per University rules.
- (2) If a student for any exceptional reasons fails to attend 75 % of the classes, he / she may be allowed to take the end semester examination as per University rules.

2. Duration of Studies:

- (1) The curriculum of study for the B.A. LL.B. and B.B.A. LL.B. shall be spread over five academic years and shall be divided into ten semesters for the examination purposes.
- (2) The curriculum of study for the LL.B. shall be spread over three academic years, and shall be divided into six semesters for the examination purposes.
- (3) The course leading to B.A. LL.B., B.B.A. LL.B. and LL.B. degree shall not have less than 30 class hours per week including tutorials, moot court exercises, guest lectures and seminars. There shall be at least 24 lecture hours per week.

Explanations:

- (a) In order to implement the above rule of Bar Council of India 'regarding 30 class hours per week' the Colleges shall provide for minimum six lectures per subject in a week.
- (b) In order to have continuous assessment of students, the colleges may reserve one lecture (out of those six lectures) for internal assessment of students.

3. Medium of Instruction and Division of Marks:

- (1) The medium for instruction and for examination of all subjects in B.A. LL.B., B.B.A. LL.B. and LL.B. courses shall be English.
- (2) Each subject of B.A. LL.B., B.B.A. LL.B. and LL.B. courses shall be of 100 marks.
- (3) The division of 100 marks for all the subjects, except for practical training subjects, shall be as under:

University Written Examination: 80 marks. Internal Assessment by College: 20 marks.

4. Division of Marks in Practical Training Subjects:

The compulsory practical training subjects of B.A. LL.B., B.B.A. LL.B. and LL.B. shall carry the division of marks as under :

: 80 marks

(1) Practical Training Paper I - Professional Ethics and Contempt of Court Law:

(a) University Written Examination

(b) Written submissions and viva voce examination : 20 marks

(2) Practical Training Paper II - Alternate Dispute Resolution System

(a) University Written Examination : 80 marks

(b) Written submissions and viva voce examination : 20 marks

(3) Practical Training Paper III - Drafting, Pleading and Conveyance:

(a) University Written Examination : 80 marks

(b) Written submissions and viva voce examination : 20 marks

(4) Practical Training Paper IV - Moot Court Exercise and Internship:

(a) Moot court exercises (40 Marks), Observance of trials (20 Marks) : 80 marks and Pre-trial preparations (20 Marks) activities

(b) Written submissions and viva voce examination : 20 marks

5. University Written Examination (80 Marks):

- (1) There shall be University written examination of 80 marks for each subject at the end of each semester of B.A. LL.B., B.B.A. LL.B. and LL.B. courses.
- (2) There shall not be University written examination for Practical Training Paper IV Moot Court Exercise and Internship.
- (3) The University, while conducting a written examination of any subject, may provide a same question paper for the students of B.A. LL.B., B.B.A. LL.B. and LL.B. courses if the concerned subject is common to those courses having same syllabus.

6. Question Paper Pattern for University Written Examination (80 Marks):

The question paper for University written examination of each subject, except for Practical Training Paper IV - Moot Court Exercise and Internship, shall be as under:

(1) Part A Questions (45 marks):

Part A of question paper shall consist of essay type questions or questions of critical comments depending on the nature of subject. A student has to answer the questions with critical evaluation. There shall be five questions and the student has to answer any three questions. Each question shall be for 15 marks.

(2) Part B Questions (20 marks):

Part B of question paper shall consist of short essay type questions depending on the nature of subject. A student has to answer the questions explaining concepts with illustrations. There shall be four questions and the student has to answer any two questions. Each question shall be for 10 marks.

(3) Part C Questions (15 marks):

Part C of question paper shall consist of short answer questions or solving of hypothetical problems, etc. There shall be five questions and the student has to answer any three questions. Each question shall be for 5 marks.

The question paper pattern given herein may be changed or altered by the University at any time without prior information to the students. The question paper pattern given herein may also be changed or altered by the University depending on the nature of subject.

7. Internal Assessment by College (20 Marks):

- (1) The division of 20 marks for each subject, except for practical training subjects, for internal assessment shall be as under:
- (a) Written Submissions: 10 marks.
- (b) Class Performance: 10 marks.

Though the division of marks for internal assessment by College i.e. written submissions and class performance, is given separately, the student has to complete both the activities as per specified rules.

- (2) The written submissions of a student may include essay writing, project writing, case comments, writing answers of given questions, or any other assignment activity given and conducted at the discretion of College.
- (3) The written submissions made by the student, as required for any subject, means handwritten submissions. In this matter, the College may grant a reasonable concession to the persons with disabilities.
- (4) The class performance of a student may include viva voce / presentation on written submissions, punctuality, participation in class discussion, seminar presentation, participation in any other class activity conducted at the discretion of College.
- (5) The method of internal assessment given hereinabove shall be applicable to the students admitted in the academic year 2019-20 and thereafter under the revised curriculum i.e. 2017 pattern.
- (6) The method of internal assessment given hereinabove shall also be applicable to the students admitted in the academic year 2017-18 and 2018-19 and who have failed in or remained absent for any subject or subjects in internal assessment component.
- (7) The evaluation of written submissions and class performance in each term or semester shall be conducted by the college before the University written examination.
- (8) The internal assessment marks may be withheld or withdrawn by the college on the ground of non-fulfillment of the attendance requirement by the student as prescribed by the University rules.
- (9) The College, for the purposes of inspection by the University, shall maintain and preserve the record with respect to written submissions and class performance, at least for two academic years excluding the year of evaluation.

8. Conduct of Viva Voce Examination for Practical Training Subjects:

- (1) The viva voce examination for the practical training subjects shall be conducted in accordance with the schedule prepared by the University.
- (2) The viva voce examination for all practical training subjects shall be conducted by the committee of examiners.
- (3) The committee of examiners shall consist of one internal examiner and one external examiner. The external examiner shall be appointed by the University from amongst the teachers in other affiliated colleges. The internal examiner shall also be appointed by the University from amongst the teachers working in the concerned college, preferably from the teachers teaching / conducting activities of the concerned practical training subject.
- (3) The committee of examiners shall not take viva voce examination of a student unless he / she submits a duly assessed written submissions at the time of viva voce examination.
- (4) The committee of examiners shall not submit the marks to the University unless the student appears for viva voce examination. In other words if the student submits a duly assessed written submissions without appearing for viva voce examination his / her marks shall not be submitted to the University.

Explanation: The written submissions by the student, as required under any of the practical training subjects, means handwritten submissions. In this matter, the College may grant a reasonable concession to the persons with disabilities.

9. Sports & Physical Education Examination : The sports & physical Education Examination shall be conducted in every academic year. The students should qualify the fitness test to obtain a degree as per uni. circular for more details and updated circulars you can visit S.P.P.U.

PART V Standard of Passing for B.A. LL.B., B.B.A. LL.B. and LL.B.

1. Standard of Passing for B.A. LL.B., B.B.A. LL.B. and LL.B. Courses:

- (1) In case of any subject of (a) B.A. LL.B., (b) B.B.A. LL.B. and (c) LL.B. Courses a student must obtain not less than 40 marks to pass a subject.
- (2) The total marks of a subject, except for practical training subjects, shall be computed by adding marks of University written examination and internal assessment. There shall be separate passing for University written examination and internal assessment of a subject. A student must obtain not less than 32 marks to pass University written examination of a subject. A student must obtain not less than 8 marks to pass internal assessment of a subject.
- (3) The total marks of practical training subjects, except for Practical Training Paper IV Moot Court Exercise and Internship, shall be computed by adding marks for two components (a) University written examination, and (b) written submissions and viva voce examination. There shall be separate passing for these two components of a subject. A student must obtain not less than 32 marks to pass a University written examination of a subject. A student must obtain not less than 8 marks to pass a written submissions and viva voce examination of a subject.
- (4) The total marks of Practical Training Paper IV Moot Court Exercise and Internship shall be computed by adding marks for two components (a) moot court exercises, observance of trials, pre-trial preparations activities, and (b) written submissions and viva voce examination. There shall be separate passing for these two components of a subject. A student must obtain not less than 32 marks to pass in a moot court exercises, observance of trials, pre-trial preparations activities of a subject. A student must obtain not less than 8 marks to pass a written submissions and viva voce examination of a subject.
- (5) A student shall be declared as passed in a particular year or class if he / she have passed in all the subjects of two terms or semesters of a year or class taken together.
- (6) There shall not be a separate passing for a single semester or term examination.
- (7) The class shall be awarded to the student if he / she have passed in all the subjects of two terms or semesters of a year or class taken together.
- (8) A student shall be entitled to the benefit of grace marks or additional marks for extracurricular activities as per University rules.
- (9) The rule of scaling down of internal assessment marks shall be applicable if percentage of internal assessment marks exceeds percentage of University written examination marks by more than 15%. The difference between the percentage of University written examination marks and percentage of internal assessment marks of a student for any subject shall not be more than 15%. If the percentage of marks obtained by a student for any subject in internal assessment exceed the percentage of marks obtained by him / her in University written examination by more than 15%, the marks obtained by him / her in internal assessment shall be brought down to that extent.

(10) The rule of scaling down of internal assessment marks shall not be applicable to practical training subjects.

(11) The class shall be awarded to the student for the year or class as under:

S.N. Percentage of Marks Class

(i) Aggregate 40% and more but less than 50% Pass Class

(ii) Aggregate 50% and more but less than 55% Second Class

(iii) Aggregate 55% and more but less than 60% Higher Second Class

(iv) Aggregate 60% and more but less than 70% First Class

(v) Aggregate 70% and Above First Class with Distinction

2. Eligibility for Award of Degree:

- (1) A student passed examination of third year of B.A. LL.B. shall be eligible to obtain the first degree of B.A. under the integrated B.A. LL.B. course. Provided that he / she has passed examination of second year of B.A. LL.B. Such a degree of B.A. shall not entitle the student to enroll as an advocate.
- (2) A student passed examination of third year of B.B.A. LL.B. shall be eligible to obtain the first degree of B.B.A. under the integrated B.B.A. LL.B. course. Provided that he / she have passed examination of second year of B.B.A. LL.B. Such a degree of B.B.A. shall not entitle the student to enroll as an advocate.
- (3) A student of B.A. LL.B. course passed examination of all the years or classes, divided in ten semesters, shall be eligible to obtain the B.A. LL.B. degree.
- (4) A student of B.B.A. LL.B. course passed examination of all the years or classes, divided in ten semesters, shall be eligible to obtain the B.B.A. LL.B. degree.
- (5) A student of LL.B. course passed examination of all years or classes, divided in six semesters, shall be eligible to obtain the LL.B. degree.

3. Allowed to Keep Terms (ATKT) for B.A. LL.B. Course:

Allowed to Keep Terms is the process to allow student to take admission and study in the next class or year even if he / she has failed in specified number of subjects. The rules of ATKT for B.A. LL.B. Course are as under:

- (1) If a student passes in not less than 2/3 of total subjects to pass, his result status will be Failed ATKT. The table given below shall decide the ATKT status of a student.
- (2) In computing "total subjects to pass" for a student from 2003 Pattern admitted in the revised curriculum i.e. 2017 Pattern, the additional subject or subjects required to pass under the Rules of Equivalence (Rules of Absorption), shall not be taken into account.
- (3) A student of Second Year B.A. LL.B. shall not be eligible for admission to Third Year B.A. LL.B. unless he / she have passed First Year B.A. LL.B. examination.

- (4) A student of Third Year B.A. LL.B. shall not be eligible for admission to Fourth Year B.A. LL.B. unless he / she have passed Second Year B.A. LL.B. examination.
- (5) A student of Fourth Year B.A. LL.B. shall not be eligible for admission to Fifth Year B.A. LL.B. unless he / she have passed Third Year B.A. LL.B. examination.

4. Allowed to Keep Terms (ATKT) for B.B.A. LL.B. Course:

Allowed to Keep Terms is the process to allow student to take admission and study in the next class or year even if he / she has failed in specified number of subjects. The rules of ATKT for B.B.A. LL.B. Course are as under:

- (1) If a student passes in not less than 2/3 of total subjects to pass, his result status will be Failed ATKT. The table given below shall decide the ATKT status of a student.
- (2) A student of Second Year B.B.A. LL.B. shall not be eligible for admission to Third Year B.B.A. LL.B. unless he / she have passed First Year B.B.A. LL.B. examination.
- (3) A student of Third Year B.B.A. LL.B. shall not be eligible for admission to Fourth Year B.B.A. LL.B. unless he / she have passed Second Year B.B.A. LL.B. examination.

Allowed to Keep Terms is the process to allow student to take admission and study in the next class or year even if he / she has failed in specified number of subjects. The rules of ATKT for LL.B. Course are as under:

- (1) If a student passes in not less than 2/3 of total subjects to pass, his result status will be Failed ATKT. The table given below shall decide the ATKT status of a student.
- (2) In computing "total subjects to pass" for a student from 2003 Pattern admitted in revised curriculum i.e. 2017 Pattern, the additional subject or subjects required to pass under the Rules of Equivalence (Rules of Absorption), shall not be taken into account.
- (3) A student of Second Year LL.B. shall not be eligible for admission to Third Year LL.B. unless he / she have passed First Year LL.B. examination.

6. Duration to Complete Entire Course:

(1) A student of B.A. LL.B. course, in order to become eligible for award of the degree, must pass in all the subjects, divided in ten semesters, within a span period of TEN academic years including academic year in which he / she was admitted to first year of the course. No student shall be admitted as a candidate for any examination of the said course after the said period of ten academic years unless he / she is readmitted to the course as a fresh candidate.

- (2) A student of B.B.A. LL.B. course, in order to become eligible for award of the degree, must pass in all the subjects, divided in ten semesters, within a span period of TEN academic years including academic year in which he / she was admitted to first year of the course. No student shall be admitted as a candidate for any examination of the said course after the said period of ten academic years unless he / she is readmitted to the course as a fresh candidate.
- (3) A student of LL.B. course, in order to become eligible for award of the degree, must pass in all the subjects, divided in six semesters, within a span period of SIX academic years including academic year in which he / she was admitted to first year of the course. No student shall be admitted as a candidate for any examination of the said course after the said period of six academic years unless he / she is readmitted to the course as a fresh candidate.

Explanation: For a student from 2003 Pattern admitted in revised curriculum i.e. 2017 Pattern under the Rules of Equivalence, the duration to complete remaining course, shall be proportional to the total duration to complete entire course given above.

Thus for example:

- (a) If a student of 2003 Pattern is admitted in Second Year B.A. LL.B. of 2017 Pattern, his / her duration to complete the course shall be eight academic years including academic year in which he / she was admitted to Second Year B.A. LL.B.
- (b) If a student of 2003 Pattern is admitted in Second Year LL.B. of 2017 Pattern, his / her duration to complete the course shall be four academic years including academic year in which he / she was admitted to Second Year LL.B.

7. Removal of Doubts and Difficulties:

Notwithstanding anything stated in the rules herein, for any unforeseen issues arising, and not covered by the rules herein, or in the event of differences of interpretation, the Vice-Chancellor of the University may take a decision and the said decision of the Vice-Chancellor shall be final and binding.

1. Absorption in Revised Curriculum 2017-18 Pattern:

- b) The student having absorbed in Revised Curriculum 2017-18 Pattern shall appear and pass the subjects as per the Revised Curriculum 2017-18 pattern. These are compulsory subjects as mentioned in column (3) in above table.

2. Rules of ATKT:

- a) The Rules of ATKT shall be as per Revised Curriculum of 2017-18.
- b) While application of Rules of ATKT, the additional subjects for which a student is required to appear as compulsory subject as mentioned in column (3) of the above table shall not be taken into account.

3. Application of Revised Curriculum of 2017-18:

Unless the context otherwise requires, if a student is absorbed in the Revised Curriculum of 2017-18 Pattern, all the rules of Revised Curriculum of 2017-18 Pattern shall be applicable.

4. Equivalence for Optional Subject for B.A.LL.B.:

- a) A student having appeared and passed for any one optional subject in V Semester of III Year B.A.LL.B. / B.S.L.LL.B. (2003 Pattern) is exempted from appearing in any one optional subject of V Semester of III B.A.LL.B. (2017-18 Pattern). However, he/she has compulsory appear for any one optional paper of VI Semester of B.A.LL.B. (2017-18 Pattern).
- b) A student having appeared and passed for any one optional subject in the VIII Semester of the IV year B.A.LL.B. / B.S.L.LL.B. (2003 Pattern) is exempted from appearing in any one optional subject of VIII Semester of IV year of B.A.LL.B. (2017-18 Pattern). However, he/she has to compulsory appear for any one optional paper of VII Semester of B.A.LL.B. (2017-18 Pattern).
- c) A student having appeared and passed the optional subject of International Economic Law in V Semester of III year B.A.LL.B./B.S.L. LL.B. (2003 Pattern) shall not opt for International Economic Law as optional subject of VIII Semester of IV year B.A.LL.B. (2017-18 Pattern).
- d) For the completion of B.A. LL.B. Course as per the Revised Curriculum 2017-18, it is compulsory for a student to have appeared and passed in six optional subjects including the exempted optional subjects.

PRACTICAL TRAINING:

It is compulsory for all LL.B. - III (3 Years Course) and B.A.LL.B. - V Year Students (5 Year Course) to undergo the Practical Training under Practical Training Paper - IV Moot Court Excercise & Internship

- 1) Attendance at the court.
- 2) Observance of the Court Proceedings;
- 3) Visits to Advocate's Chamber;
- 4) Presentation of moot court etc.

Non-Compliance with any part of Practical Training will be treated as absence of the student in the subject and No Marks will be allotted against such non-compliance.

STANDARD OF PASSING

• For LL.B. (Three years course)

To pass any examination, a candidate must obtain:

- a. 40% of the full marks in each paper
- b. 40% of the total marks in each paper

A.T.K.T. Rules:

A candidate who obtains at the 1st & 2nd years (of LL.B. three years course) 50% of the full marks in **any SIX** out of the total number of papers prescribed for the respective academic year shall be allowed to keep the terms respective for the 2nd & 3rd year of LL.B. Examination. (i.e. student should pass in 2/3 of the total paper of respective academic year.)

Provided however that he shall not be declared to have passed the 2nd LL.B. or the 3rd LL.B. Examination unless he has passed the 1st LL.B. or the 2nd LL.B. examination by passing at the examination.

Such a candidate shall not be eligible for a Class prize at scholarship awarded at the examination.

• For B.A.LL.B. (Five year LL.B. Course)

To pass the 1st and 2nd year of examination (Five year Law course), a candidate must obtain

- a) 40% of the full marks in each paper.
- b) 40% of the total marks in the examination.

To pass the 3rd year of B.A.LL.B. and 4th and 5th year B.A.LL.B. (Five year Law Course) a candidate must obtain. For B.A.LL.B. (Five year LL.B. Course)

To pass the 1st and 2nd year of examination (Five year Law course), a candidate must obtain

- a) 40% of the full marks in each paper.
- b) 40% of the total marks in the examination.
 To pass the 3rd year of B.A.LL.B. and 4th and 5th year B.A.LL.B. (Five year Law Course) a candidate must obtain.
- c) 40% of the full marks in each paper and
- d) 40% of the total marks in the examination.

• A.T.K.T. RULES:

A candidate who obtains at the 1st, 2nd, 3rd year of B.A.LL.B., or 4th year of LL.B. (Five year B.A.LL.B. Course) 40% of the full marks in the number subjects given below out of the total number of papers prescribed for the respective academic year shall be allowed to keep terms respectively for next year; i.e. the 2nd, 3rd year of B.A.LL.B and 4th year of B . A . L L . B . examination i.e. ATKT for 2/3 of the total subjects.

First year B.A.LL.B. examination - 4 subjects.

Second year B.A.LL.B. examination - 4 subjects.

Third year B.A.LL.B. examination - 5 subject.

Fourth year B.A.LL.B. examination - 5 subjects.

Provided however that he shall not be declared to have passed the examination of such next year, i.e. 2nd and 3rd year of B.A.LL.B. and 4th year and 5th year of B.A.LL.B. Unless he has passed such subjects and the remaining papers in the examination of such previous year according to the standard of passing laid down above. Such candidate shall not be eligible for a class prize or scholarship awarded at the examination.

MPORTANT AS PER SAVITRIBAI PHULE PUNE UNIVERSITY

Circular No. 373/2004, Dtd. 16/10/2004, a candidate who has not passed any particular examination during the validity period of grant of term. (I.E. Six years) shall not be eligible to appear for that particular examination after the validity period of grant of term. (I.E. six years) is over.

INCENTIVE MARKS

(Additional marks for extra-curricular activity)

Five additional marks may be granted to candidate appearing for University examination of any degree, diploma or certificate, as an incentive marks for his participation in any one or more of the following activities:

- a) NCC b) NSS c) National physical efficiency drive
- d) Adult education programme of Pune University.

The additional marks shall be added:

- a) To any subject/s as the case may be in the examination if the student has failed in such subject/s and if such additional marks enable the student to get necessary passing marks.
- b) To the total number of marks, secured by the candidate in the examination. Provided that the additional marks shall not be taken into consideration for the purpose of award of any prize, scholarship merit list or for such other similar purposes. The additional marks shall be granted to the candidate only for the examination during the course of which the candidates has participated in the activities mentioned above.

NOTE: The candidate shall be eligible to get maximum five additional marks only once, for any of the activities mentioned above, if performed by him any year, and only for an examination of one course.
