However, in the joint functioning or working the names and related information can be used by either of the parties by prior written approval of the other party.

CLAUSE 4 VALIDITY

- 4.1 The Agreement is expressly entered between the parties initially for the period of two years i.e., from First of July Two Thousand Twenty-One to Thirtieth of June Two Thousand Twenty-Three.
- 4.2 This Agreement will be valid until it is expressly terminated by either Party on mutually agreed terms, during which period, Navjeevan Law College, Nashik, the Second Party, and LEGAL SAVIOUR, the first party, as the case may be, will take effective steps for implementation of this MOU. Any act on the part of either parties, after termination of this agreement by way of this communication, correspondence, etc. shall not be construed as an extension of this MOU.

CLAUSE 5

Neither Party shall have, nor represent itself as having, any authority under the terms of this MOU to make arrangements of any kind in the name of or binding upon the other party, to
